Methods of processing Personal Data

Your Personal Data shall be processed manually and/or using paper-based, electronic or telematic means and systems and applying the logics that are strictly necessary for the purposes indicated below.

The Data Controller does not make use of any automated individual decision-making in the processing of your Personal Data.

Purpose of the processing
